

DIREWOLF EXPRESS* DOG TRANSPORTATION WAIVER AND LIABILITY OF RELEASE



DireWolf Express cares deeply about the well-being of its canine guests and looks after them to the best of its ability while seeking to provide the best possible care. Please read and acknowledge the following before submitting your application.

I understand that dogs can sometimes be injured or become ill during transportation and understand that every dog reacts differently and that animals, by nature, are unpredictable. Therefore, for myself, my heirs and assigns, I have read, understand, and agree to the following:

- I hereby waive, release, and discharge DireWolf Express and its owners, agents, officers, employees, or volunteers from any and all liabilities that result in injury to, or the loss of my dog(s), or any other property of mine which arises in any way out of the transportation provided by DireWolf Express.
- I hereby agree to defend, indemnify, and hold harmless DireWolf Express, its owners, agents, officers, employees, or volunteers from and against any and all claims of any nature including all costs, expenses and attorneys' fees, which arise in any way out of the transportation provided by DireWolf Express.
- I understand that DireWolf Express will be providing transportation for my dog(s). DireWolf Express agrees to exercise reasonable care of my dog(s) during transportation. I acknowledge that allowing DireWolf Express, its owners, agents, officers, employees, or volunteers to transport my dog(s) involves risks of injury to my dog(s) during transportation. I knowingly accept and assume all known and unknown risks in allowing my dog(s) to be transported.
- I recognize the risk of injury that accompanies transportation of my dog(s) and acknowledge that this release is being relied upon by DireWolf Express to permit transportation of my dog(s) from DireWolf Dogs of Vallecito, LLC located at 5502 Hwy 25 S Fruitland, Washington 99129 to my home as stipulated on the DireWolf Dogs Puppy Contract, or any other necessary location, such as a veterinarian facility.
- I accept any and all conditions, rules, and regulations promulgated by DireWolf Express, associated with the activities, use of the DireWolf Express facilities and transportation, and hereby agree to comply with them.
- DireWolf Express will take precautions to prevent dogs from running away from their vehicles or property but dogs' behavior cannot be perfectly controlled at all times. I will not hold DireWolf Express responsible if my dog finds a way to flee their premises during care or automobiles during transportation.

- DireWolf Express may, at any time, remove a dog from transport, or refuse a dog transportation, if the dog exhibits behavior that could be harmful to the dog, other dogs, or staff, such as:
 - Aggression or uncooperative behavior;
 - High anxiety or fear;
 - Refusal of dog to load into vehicle;
 - A condition or behavior rendering dog generally not fit for transportation;
 - If, in the opinion of DireWolf Express employee or agent, transportation is not in the best interest of dog.

- I understand that dogs can sometimes be injured or become ill during transportation. I accept that DireWolf Express is not in any way responsible for any injury, stress or illness my dog(s) may suffer while under DireWolf Express' care or while being transported by DireWolf Express. I will not hold DireWolf Express liable, financially or legally, for any physical, mental, or health issues that arise during or as a result of my dog's transportation by DireWolf Express. This includes, but is not limited to: dog bites, minor cuts and scratches, bone breakage, tissue damage, joint problems, stress, or diarrhea.

- This agreement shall be governed by, and construed in accordance with, the laws of the State of Washington.

I, the undersigned, affirm that I am at least 18 years of age and am freely signing this Waiver and Liability Release. **I have read this Waiver and Liability Release and fully understand that by signing this Waiver and Liability Release I am giving up legal rights** and/or remedies which may otherwise be available to me regarding any losses I may sustain. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.
